- 1. Discussion on *interim jerseys* for the 2021/2022 season
  - This season we intend to purchase interim jerseys, these jerseys will not be as high quality as our current game jerseys. They are our first step towards rebranding. Interim jerseys will have Blackhawks diagonally across the front of them without a logo. No decisions have been made on a name or what the new logo will be at this time. The membership and community will be consulted before any permanent decisions are arrived at.
  - Rob & Steph went out for quote for interim jerseys. Rob went to Dynamic in Corunna and Steph went to Team Outfitters. Lynz gathered a quote from Planet Stitch as well.
  - We discussed only replacing the teams that travel outside of our center for this season first and focus on the younger divisions later, however, all were in agreement if we could afford to do all Divisions, that was ideal.
  - We will be using fundraised (Bingo) dollars to pay for the interim jerseys. This money needs to be spent on tangible items that remain with the organization. We discussed downloading the cost to the registrants but decided that was not ideal given Covid hardship etc. These jerseys will become our practice jerseys once we land on a permanent logo. PEMAA will absorb the cost of the interim jerseys.
  - Would we like to add a small logo on an arm of the jerseys for Every Child Matters.
    - Steph is going to inquire about pricing on this option.
  - Note that ALL name bars will need to be removed this season and attached to the interim jerseys, fee for attaching namebars will be higher this season.
- 2. Erin motioned to purchase transitional jerseys for the 2021/2022 season to be worn instead of the current game jerseys for all divisions.
  - The jerseys should be assessed part way through the season to see how they are holding up.
  - Jane second the motion All in favour; motioned passed

- 3. Lynz motioned to use Team Outfitters quote for jerseys (Jersey # 6500 was picked)
  - Erin second the motion All in favour; motioned passed
- 4. Jane motioned to order 1 black set & 1 red set of jerseys for each team; If our OMHA representative does not approve this since we will not have 1 dark & 1 light jersey then black & white jersey's will be ordered (Liz to follow up at the Aug 3<sup>rd</sup> meeting if we have not received and answer).
  - Steph second motion All in favour; motioned passed
- 5. Discussion on various fund-raising ideas
  - Pizza kits have been secured for Dec
  - Steph is working on a few ideas updates to come when things are more final.
  - Freeze Dried skittles possible other snacks opportunity for fund-raising.
  - Meat Raffles will hopefully be an option
  - Bingo will remain an options as soon as COVID allows
- 6. Lynz passed a motion to do freeze dried skittles fund-raiser
  - Steph second motion All in favour; motion passed
- 7. We are interested in hosting the ALL STAR GAMES this year if the opportunity is available
  Need to start looking at dates in March to host to book ice time.

  o More information will be available at a later date.

  - Sarnia first payment \$300 second payment \$250

  - Jane suggested payment at the beginning of season and second payment in Dec.
- 10. COVID clinic is wrapping up August 10<sup>th</sup> at our arena Hockey season will not be delayed!!! yahoooooo
