Regrets:

- 1) Financials Lynz
 - Lynz reviewed the current bank balances
 - 1 GIC has been moved to cashable this will help with cashflow if needed, for the 2021/2022 season
 - Village donation cheque to be deposited
- 2) Hockey Batch Registration/online pre-registration Jane/Liz
 - 8 divisions have been pre-registered
 - Each division may need to be split pending COVID rules however there will not be any extra fees
 - Coaches & preschool not registered no fee associated
- 3) Equipment Rob
 - We have good stock on equipment
 - Will need to do a pre-season PPE check-up and top up items where needed
- 4) LMLL Liz
 - We won't know what 2021/2022 season looks like yet. Start of the season may be strictly development but that is unknown still. Dependant upon stages for each region, we will need to wait on direction from OMHA & LMLL
- 5) Soccer
 - Darryl has updated the website so all soccer emails go directly to Liz for the time being
 - We may want to look at having an ad hoc board member be the Soccer Liaison next year
 - Unanimously Voted not to run soccer program again this year due to COVID restrictions

- 9) Registration & Fees

 - Arena is not available until Oct due to Health Unit contract of use.

- 14) Rebranding
 - Lynz & Rob getting quotes for practice jerseys Red & White with just Blackhawks on the front, black hawk colouring no logo, name & number on back.
 - To be discussed at next meeting after information is collected do we discussed adding ~ \$100 to registration fees to cover cost of above jerseys for each player and players can keep jerseys at end of season like Sarnia however, we realize that could be difficult for parents
 - Maybe use Survey Money idea for input and inquire about keeping name/new name, keep colours/change colours etc
 - There has been no push back to change our name the logo is the outside focus
 - Liz has been in touch with the Village updating them around what we have been able to accomplish thus far and what is still outstanding.
 - Jersey replacements of current logo are only done as required. Full sets of jerseys will not be replaced until rebranding
